

NORTH SYDNEY JUNIOR LEAGUE DELEGATES REPORT

This season saw the implementation of the Code of Conduct for the North Sydney District based on the National Standards set in 2004. It is pleasing to report that with the added focus on participant's behaviour the incidence of unacceptable behaviour was vastly reduced in 2006. It is obvious that there is a great awareness in the district of the COC and I would like to congratulate the clubs for their support of the document and related procedures.

For referees it means that there is a far greater chance that you will not be subject to intimidation, harassment, or abuse at a ground and if this were to occur then there is now a formal process to call the transgressor to account. Perhaps one of the most controversial aspects of the COC has been the realisation from clubs that they are responsible for the behaviour of all spectators at the ground. As referees it is important to be aware that your own behaviour must be of the highest standard at all times and you must not leave yourself open for complaint in the standards that you maintain.

Up and coming referees in the NS District have a great head start should they have ambitions of achieving at the top level in the game. Experienced administrators, advisors, and coaches such as Michael Quailey, Col Jones, Martin Ryan, and Stan Watson to name a few give the up and coming referee every opportunity to develop. However as I have said many times before ultimately success in the sport is largely up to the individual referee who must have steely determination and dedication to fitness, rules knowledge, and continuous improvement. For the referee who is content to remain at the local

district level it is fair to say that the friendship and social aspects remain very strong.

I believe for the district to move forward in 2007 and beyond there will need to be more integration between districts as the level of competition and number of teams has gradually declined over recent years. This will need an open minded and cooperative approach from all stakeholders. I am sure this will be a topic of discussion at the end of season review meeting between the Junior League and the Referees that was agreed to last season. I am sure another topic will be any new initiatives that may be implemented to attract new referees.

The position as Junior League delegate will become vacant next year as increasing work commitments and the likelihood of an overseas posting become reality. I would like to thank Jon Stone for filling in on a few occasions the year.

INCIDENT REVIEW COMMITTEE REPORT

The 2006 season has seen the introduction of a new process for managing the conduct of all those involved in the game other than players on the field. This includes coaches, managers, trainers, Club office bearers, Junior League office bearers, referees and club supporters.

Any misconduct by any of these participants reflects badly on the whole Game, and could easily result in players leaving the Game, or parents withdrawing their children from the Game. Also, where that misconduct involves abuse of referees, it can cause our Association unhelpful extra challenges in referee recruitment and retention. Hence the good conduct of all these participants in the Game is critical to the future success of our code, both in North Sydney and beyond.

While abuse of match officials has been a perennial problem over the years, it would be quite accurate to say that it became noticeably worse in 2005. What was equally concerning was the lack of any formalised and time-bound process for dealing with it.

The good news is that in 2006 the Junior League, with active support from the Referees Association, tackled the problem head on, and introduced an effective and workable new process. What is equally as pleasing is that the new process has generated a noticeable improvement of all participants in their attitude towards misconduct. It has also reinforced the important concept that Clubs are

responsible for the behaviour of their own members and supporters. That underlying attitudinal change, if sustained, will actually prevent conduct issues from occurring, and hopefully prevent the need for any remedial action to be required in 2007.

The new process is documented in a Policy and Procedure manual, and all referees and Clubs have received copied of it. It outlines the way in which the North Sydney Junior League applies the ARL's National Code of Conduct. The new process places new responsibilities on referees, so it is imperative that all members are familiar with the process, and follow it exactly. This is essential if we are to continue to benefit from it, and ensure it retains the broad support it currently has throughout the Junior League.

The new process includes a body called the Incident Review Committee (IRC). The role of this body is to assess Code of Conduct Breach Notices immediately after they have been issued, to determine whether the matter requires action under the guidelines, and it so to ensure that action is taken within a clearly defined timeframe. That action can include a Junior League Board hearing or a Judiciary hearing. Where the facts are not in dispute and the matter is not considered to be serious, a warning letter can also be issued directly by the IRC. In the 2006 season, about 8 Breach Notices were issued. From these, 2 hearings were convened and 3 warning letters issued. The hearings resulted in bans from attending matches, and other measures. While the process requires some further refinement, and the process documentation could be greatly simplified, the process proved itself effective in its fist season, as the above statistics demonstrate.

I acted as our Association's representative on the IRC. I found it a meaningful and rewarding experience. I would like to acknowledge the positive contribution of my fellow IRC members in developing the procedure: Kevin Nicholls and Peter Stanborough.

I would encourage other referees to consider taking the role in future. It is a way to make a contribution to the Association and Junior League, without any specific commitment to dates or times, and with a manageable number of hours needed overall.

DIRECTOR OF FINANCE REPORT

Mr Chairman and members,

It gives me great pleasure to serve as your Finance Director for the 2006 season. This season the Association operated under a new system of a board rather than a committee. It was a learning experience for all and I believe it will continue to be a learning experience for the incoming board of 2007. The season again resulted in deficit due to the expenditure for the new communications equipment and the write off of the old communication equipment earpieces.

Unfortunately this season again saw the Association was without a sponsor. Again the 2006 season the Association could not pay our members their match payments before the end of the financial year. It appears as though there is a system issue with the Leagues Club. A memo was issued to all the club's creditors in June. We received this memo together with the cheque for the final match payments on 19th November. Now we are aware of the clubs direct credit procedure, we will ensure future payments are made into the Association's bank account in a timely manner. The debtors and creditors figures in the balance sheets are the accrued amounts receivable from the Leagues Club and net payments to members.

As you can see by the income and expenditure statement for the 2006 season the Association made a deficit of \$3,671.34. Revenue for the year was relatively the same as 2005. This is surprising due to the limited number of fixtures. This can be explained by the increase in match payments to referees. On the expenditure side, if we disregard the write off of the gear and payment of the communications equipment the Association would have made a surplus of \$145.61.

I mentioned in my report last year that a procedure of gear was required for the 2006 season due to the continual write off and inventory "walking away". This season saw a dramatic turn around. All gear was accounted for. This could not have been achieved without the dedication and diligence of Luke Kelso who acted as our gear steward. I would like to thank Luke for his assistance this season, a job well done.

Finally thank you to my fellow Board members for your support throughout the year. I look forward to season 2007 and I hope it will be as enjoyable as 2006.
