PRESIDENT'S REPORT

Fellow Members,

It gives me great pleasure to write these few words for our 2003 Annual Report.

All members are to be congratulated for their efforts throughout the season. It was, on reflection, a difficult season for all of us.

Before the season commenced, we lost a number of active members through study, work and family commitments. Then as the season progressed, we lost a few more through illness and work commitments. This placed a great strain on the resources of our Association and our ability to meet our obligations to the Junior League.

Fortunately, our friends at Manly were able to assist us with the matches played in the Manly area. To Dave Jay, President Rob Peard and the members at Manly who were appointed, thank you for your efforts.

Special mention must be made of four of our members, who, without their efforts and commitment, we could not have made it through to the end of the season.

Firstly, thank you to Col Jones and Martin Ryan. Both Col and Martin retired from their distinguished Grade careers at the start of the season. They probably did not envisage playing the role they did throughout 2003 but without them, we would have really struggled. Col became reacquainted with the cricket pitch at Willoughby Park and realised it was still as hard as ever.

Now to Stuart Kidd and Curtis Dowel. These gentlemen are, for the moment, the backbone of our Association. Their commitment to refereeing and their willingness to do whatever is asked of them, without complaint, is an example to all of us. In 2003 there were 1,280 appointments. Stuart and Curtis accounted for 215 of those appointments between them. This is just a little over 16 percent; a phenomenal effort when you consider it is double the average (which is 4 percent per Active Member). In a nutshell, they have each done the work of two people. Thank you Stuart and Curtis for your tireless efforts.

As mentioned in previous years, coaching is the backbone of any Association. We were able to add to our coaching ranks this year when Curtis Dowel and Cameron O'Riordan successfully gained their Level 1 accreditation. We now have five accredited coaches, which equates to approximately one coach for every five active members, an excellent ratio which should only improve our on field performances.

Through the efforts of our Accreditation Provider Brian Minnett, two new members joined us this year. Welcome to Dom Paton and Steve Schulz. Dom in particular showed great enthusiasm for his new role, even turning up for two of our seminars. Both have a bright future ahead of them.

2003 saw us commence a relationship with Group 10 Referees. Centred around the Bathurst area but extending to Orange, Lithgow, Mudgee, Oberon, Cowra and Blaney, a wide area is covered. Given the distances these referees travel to fixtures, no more complaints about travelling to Hitchcock and Lake Parks' will be entertained.

Through the efforts of their Secretary Peter Clifford an exchange program was implemented in the lower grades. In June Wayne Edwards, Curtis Dowel and myself made the trip up to a rather chilly Bathurst where Wayne and Curtis ran fixtures while I watched one of their Reserve Grade referees. The hospitality was first class and we met local refereeing identities such as "Porn Star" and "Killer".

The reciprocal visit took place in early August when Peter and President Ian brought down Glen Stapleton and Jeremy Toole. They were appointed to fixtures at Greenway Park where they were under the eye of our own Stan Watson. That evening, through the generosity of NSW Referees, we went to the Parramatta V Wests Tigers match at Parramatta Stadium where the boys were shown the ins and outs of the Video Referee room, thanks to Graeme West.

Next year, we hope to expand these visits.

It would be remiss of me not to thank the NSW Rugby League Referees Association's continued support in providing grants, which greatly assist in easing the financial burden of running our Association. Through a restructure, Head Body now have in place the Affiliate Liaison Committee, which encompasses our Association. Thanks to Brian Gilchrist and his Committee for their work in 2003 and for making the visit by our Group 10 friends a memorable experience for them.

Also, many thanks to Junior League Administrator Kevin Nicholls, President Gordon Thurgood and the Board of the Junior League and North Sydney Leagues Club for your continued support. We may not always see eye to eye but our common goal is to continue to ensure that the game of Rugby League is always played in North Sydney.

Now to our Committee Members:

- ➤ Patron Bill Lalor: a great stalwart and supporter of all our members.
- > Secretary Adam Devcich: continued on well with in his third year as Secretary, did a commendable job while maintaining a high standard on

the field. Hopefully, next year will see him achieve his goal of being called into Grade (not that we want to get rid of him).

- ➤ Treasurer Michael Haynes: stepped in when asked and did a great job while still balancing work and Uni commitments. Helped us out on the field as well when he could. Many thanks for your efforts.
- ➤ Senior Vice President Martin Ryan: following on from his Grade retirement his deep commitment to our Association was even more evident despite his family obligations.
- Intermediate Vice President Stan Watson: Stan plays a vital role in the Association through his efforts as a coach and advisor while holding a position on the NSWRL Advisory Board. Stan had an outstanding 2003 and was a very worthy recipient of the Bob Purcell Trophy. Not many people would realise the hours Stan spends reviewing the videotapes of the games he tapes or the hours on the phone with me discussing the day's performances. Also, Stan acquired our sponsorship from Frozen Concepts. Thanks Stan for all your efforts.

SECRETARY'S REPORT

Dear Members,

The temperatures have started to rise and Daylight savings is upon us – which again means the footy season has come to an end.

At the beginning of 2003 the Association was without a sponsor. However, early in the season through Stan Watson, Frozen Concepts, agreed to sponsor the Association for the year, with a view to extending that sponsorship into 2004. However, at this point we do not have the logo for Frozen Concepts. Once this has been received (and the Sponsorship is continued) it will appear on our onfield gear in 2004. A big thank you to Stan for organising the sponsor!!!

Without a current NRL team, these years between losing the Bears from the NRL and their hopeful resurrection are extremely important to keep Rugby League prospering in the area. It is therefore essential to have a hardworking and visible Management to help achieve this. With Greg Florimo and Gary Larson joining the District club and the end of last year, we have two guys that are committed to rugby league in the area. Gary and Greg were involved not only in the District club, but also made appearances at Junior League grounds throughout the year.

Along with Gary and Greg, Rugby League is managed in North Sydney by our Junior League Administrator, Kevin Nicholls and Junior League President, Gordon Thurgood, who do a terrific job in co-ordinating our own Junior League competitions and the cross boundary competitions with Manly (with some teams from South Sydney involved this year as well) with the co-operation of Manly Junior League President, Col Burdon and his board. Thank you to all of these guys, as without your efforts in keeping the Junior League alive, our Association would have no games to referee!!

With these cross boundary competitions with Manly, we obviously need a close working relationship with the Manly Referees' Association. This has developed greatly over the past few years and our sincere thanks goes to Manly Referees' President, Rob Peard and their Director of Referees', David Jay for their cooperation throughout the year. As a tribute to how our Associations' relationship has developed, now it is not unusual to see referees' from both North Sydney and Manly officiating together on the same ground and sometimes on the same games.

The junior and senior Grand Final days were held back to back over one weekend in August this year, with ten Grand Finals held in total, form under 9 to 16 and then A2 and A1. These are the most Grand Finals held in North Sydney for a number of years. Congratulations to the Belrose team for winning the A1 competition in their first year in the North Sydney competition. This was the third successive year the North Sydney A1 competition has been won by a team from outside the District. This year also saw the junior winners of the North Sydney Grand Finals play the winner of their counterparts in the Manly competition, under the banner of the Ken Irvine Shield. This was another great initiative by both Junior Leagues' and will hopefully continue in the years to come.

Our physical trainer again this year was Kate Watson. Once again she did a great job and we thank her for the effort she puts into, not only turning up each week given her busy schedule but the organisation she puts into preparing the sessions. Kate also took on the role of Primary Schools Development Officer with North Sydney this year and works tirelessly to promote rugby League in the District.

Attendances at training dwindled somewhat this year, partly due to a loss of a number of active members. However, the encouraging sign is that most of our junior members had a terrific record at training this year. Given our small numbers of active referees', the attendances at meetings was quite good, so thank you to all those members that take the time to keep attending them.

Socially this year was quite poor – again. Again there were some activities organised that had to be cancelled due to lack of interest. The one function that was held was the Annual Presentation night, which was well attended by the members. Thanks to Scot Murray for his organisation of the night.

Stephen Clark once again headed our representation in the NRL in 2003. With Bill Harrigan now retired, the door is now wide open for State of Origin and other representative appointments and Stephen definitely be one fighting it out for the top spot. Good luck Stephen!!! Tony Archer spent some time in the NRL this year both in the centre and as a touch judge and would be hoping for more time up there in 2004.

Gerard Bailey started the year in fine style, by spending 6 weeks on the sideline after tearing tendons in his ankle. After his recovery, he spent his first full year in the NSW graded ranks touch judging both Jim Beam Cup and Premier League. He to will be looking for the higher grades in 2004. Stan Watson was again on the NSWRLRA advisory board and also gained his level two referees' coaching badge (along with Michael Quailey and Jon Stone, while Cameron O'Riordan and Curtis Dowel received their level one referees; coaching badge).

The Association would like to thank Tony Danks, Les Mathews and the Board of Management of the NSWRLRA for their financial assistance throughout the year. We would also like to thank Bryan Gilchrist and the inaugural affiliate liaison committee for their support and advice throughout the year, in helping the District Associations' communicate and share ideas with one another. This committee (including our own Colin Jones) has been a tremendous addition to the NSWRLRA structure.

To our advisors again we say thanks you for your tireless efforts. Thank you for liking what you do enough, to continue to do it year after year, both as advisors and in most cases as holders of positions on committees etc. These include, John Quinn, Brian Minnett, Michael Quailey, Stan Watson and a younger brigade in Jon Stone, Cameron O'Riordan and Curtis Dowel.

I must give a special mention to our President Michael Quailey, who also sends out our appointments and along with John Quinn, is our primary liaison with the Junior League. Michael is currently the glue that holds the Association together.

Thank you also to our active members, whose commitment to turning up each week (especially with the shortage of numbers we have) is essential to the health of Rugby league in the District. Your consistent dedication to refereeing is very much appreciated.

Finally, we cannot say goodbye to 2003 without mentioning two North Sydney members that ended two very distinguished careers in the NSWRLRA graded ranks.

Colin Jones has been one of the most successful touch judges in recent history, including appointments to both State of Origin matches and a Test Match. He also spent a number of years as a first grade touch judge and officiated in Premier League Grand Finals, the last being in 2001, to name a few of his achievements. He is a life member of this Association and is still involved at NSWRLRA level as a member of the affiliate liaison committee. This year he returned to the centre at district level and was appointed to the 'A1' grand final touch line.

Martin Ryan has also scaled the heights in the NSW grade ranks as a touch judge. Amongst his achievements are a number of first grade touchlines, a State of Origin in-goal appointment and Premier League Grand Finals. Martin was also one of the driving forces behind the changing of the NSWRLRA Constitution in 2002 and received the coveted Hanson Award, as outstanding NSWRLRA Association member in 2001. Martin is also a life member of this Association and also returned to district football in 2003.

On behalf of this Association, I would like to congratulate both Colin and Martin on their distinguished careers in refereeing. Their retirement from grade means does mean a degree of change in lifestyle and we wish them good luck and happiness for their future endeavours both on and off the football field.



North Sydney Referees Association Inc is proud of the fact that a number of members are either graded or in the Development Squad. The break down and qualifications of those members and where they finished season 2003 is as follows. First the graded members.

Steven Clark:

Refereed in the NRL. Steven had an injury free season, refereeing in the NRL. Apart from refereeing, Steven also performed the role of Video Referee at NRL fixtures on the same weekend. Steven maintained his level of fitness and this was evident, as Steven did not miss one NRL fixture. Steven finished the season controlling an NRL Quarter Final and being appointed Video Referee to the NRL Grand Final.

Tony Archer:

Anthony refereed mostly in the NSWRL competition, refereeing the Premier League. Anthony was appointed as Touch Judge the NRL Competition and also as a referee in an NRL fixture where he trailed the two referees per game concept. This year Anthony again refereed the Premier League Grand Final.

Gerard had a good season, officiating all weekend for most weekends. COACHING REPORT

Accreditation Report

Its that time of year again when you report on the years work. This year has been the leanest of all that I can remember. We started by putting the Preliminary Referees through to Level One. At this stage we held off putting the Level One Referees through to Level Two because of potential changes to the Accreditation system, which will now be introduced next year. This was sorted out at an Accreditation Meeting held at the home of Barry Ruttle (one of the coordinators of the scheme), where we were told that some Associations were not adhering to the guidelines. We were told that the associations would be policed better to see that we were doing the right thing. If you think this paragraph above seems a little confusing can you imagine what the year has been like.

Two new candidates did get through - Steve Schulz a young 16 year old who was quite enthusiastic and if looked after could develop into a good referee. Then there was Jody Rae (a former player from Warners Bay near Newcastle) who showed a lot of character in deciding to travel down here to learn and start his Refereeing career. He had great ambition to go to the top, but he decided after getting his preliminary ticket to return to Newcastle. There is Dominic Paton, a young fellow who is going to develop into a good referee.

We have two candidates waiting in the wings to start next season namely Al Rudd and Nick Monte, both of whom will be kept up to date with information on the course. Our present Level one Members - Curtis Dowel, Steve Dayeian, Andrew Whiddon and Stuart Kidd will have to wait till early next year to officially gain their Level Two ticket when they attend a special weekend for Level two Referees.

To our coaching staff Stan Watson, Gerard Bailey, Nathan Smith and help from Colin Jones and Martin Ryan and finally to our trainer/conditioner Kate Watson – thank you for all the time you gave to help our referees.

Finally may I say thank you, for all the support, friendship and help I have received from you over the many years that I have been around. I have decided to retire, I believe the game today is a young persons domain for teaching and coaching and the Association needs new and enthusiastic workers to take it forward and our association has these people.

All the very best for the coming season and keep up the good work you all have put in.

Skills Training

This year saw our three Level 2 Referees Coaches, Stan Watson, Michael Quailey and Jon Stone implement new strategies also, in particular the video taping of referees. Referees who had their game video taped received a tape of their game, which they had to view and then complete a self-assessment form, which was then reviewed, by the coaches.

Although the Association does not possess a video camera, two of the Level 2 Referees Coaches utilised their own cameras to videotape a total of 13 referees this season compared to a total of 6 in season 2002. I can honestly say that the referees who were video taped benefited from the tapes. Not all referees were video taped and I do apologise as duties with NSWRLRA Inc Advisory Board also took up some time.

This year also saw two of our members, Curtis Dowel and Cameron O'Riordan attend the Academy of Sport and undergo the Level 1 Referees Coaches Course. With a total of five Referees Coaches and very experienced members, all grounds had an adviser in attendance.

With Kate's training and improvement in fitness, along with the video taping of referees and Michael Quailey conducting a training seminar, there was a vast improvement in referees and touch judges performances, especially from our junior members who did not feel intimidated by coaches, managers, trainers or spectators.

It was evident this year with semi final and grand final appointments on how our members performed during the season. Semi finals and grand finals are not just given out and any referee appointed, all referees, touch judges and in-goal judges earned their respective appointments.

I must thank Michael Quailey for conducting the training seminars at his house. This year also saw North Sydney Referees Association conduct an exchange program with the group 10 Bathurst Referees Association. Michael, Wayne Edwards and Curtis Dowel travelled to Bathurst where they officiated in the Saturday competition.

In July two junior referees form Group 10 along with their coach and Secretary attended North Sydney Association and officiated at Greenway Park, being assessed by myself. I must add that the two junior referees showed promise. Later that evening the Group 10 referees were hosted to an NRL fixture at Parramatta Stadium where they were introduced to Mr Graeme West the Video Referee appointed to that fixture.

I will finish off by saying to the active members, do not slacken off now that the season has finished. Keep your physical training up and keep reading the rule books.

Finally I would like to thank all the members that attended the training sessions, whether it was physical, video and theory and the seminars as this showed that you were all keen to improve your capabilities.

The new season is just around the corner, so just like the boy scouts, be prepared.

TREASURER'\$ REPORT

Mr. Chairman & members,

Once again it gives me great pleasure to serve as you Honorary Treasurer for the 2003 season. I am pleased to report to you that financially this season was more successful than first anticipated.

It looked as though that again the Association would be without a sponsor for the season. However thanks to Stan Watson's efforts we were able to obtain Frozen Concepts for two seasons for a total of \$10,000. We received the first cheque in May to kick off the season with some cash in the bank. Unfortunately, our sponsor did not forward the log of his business for our members to wear on their uniforms each weekend. Hopefully this does not jeopardise the additional funds we are due to receive for the 2004 season.

As you can see by the income and expenditure statement for the 2003 season the Association made a Surplus of \$3,502.07. I believe this is a fantastic result for the year given the fact that our membership fees were down during the year due to the fall in the number of fixtures and two weekends washed out. However without the sponsorship funds the Association would have "been in the red" approximately \$1,500 and \$3,500 shorter in the bank account.

I urge all members to please read the notes to this year's financial accounts. I have added some additional information regarding the expenditure and the funds received against that expenditure. I feel it is important for members to gain an understanding of how the Association spends its member's money. These notes were prepared to offer more transparency into the finances of the Association. It also tries to achieve more prudent financial awareness and improved corporate governance. Please be aware that these notes do not reconcile to the bottom line of surplus.

Although, the surplus was a great result for the Association this year I do wish to bring up an important issues that affected the financial performance. You will notice the write of approximately \$1,300.00 worth of Association uniforms. To me this is highly unacceptable. This property of the members has reduced the net worth of the Association substantially, especially for a small one like ours. This is not a fault of Scot Murray's, I believe it is through poor control and management of the gear over a number of years. This is an 8% decrease in the net worth of the Association. This would be an unacceptable risk if the Association were a public or large private company. In the coming seasons, it is up to the committee to find a solution to this recurring problem. The total write off of gear that is

obsolete was \$595.20, consisting of the old uniform. The rest has obviously been unaccounted for somewhere along the lines.

The Association's net worth has increased by approximately \$3,500.00 dollars. This increase is up from \$12,697.59 to \$16,199.66. This figure is mainly represented by what we have in the bank account. The Association is still bearing the loss on social events, and we only had two this year, the Grand Final dinner at Martin and Mary Ryan's residence and the annual presentation night. Please be aware that without a substantial bank account the Association would be "scraping the bottom of the barrel" to subsidise these events.

The most unfortunate issue that seems to be facing the Association and most of the rugby league community is the continual slide in the number of games and players each year. This seems to bee an issue between 15 and 19 year age groups. This provides less revenue for the Association and also fewer games for our referees to gain valuable experience. It also reduces the income of our junior members who rely on these games for additional pocket money. Hopefully the rugby league foundation can do its best to increase the participation rates amongst these age groups.

I would like to thank the outgoing committee members for their assistance and friendship throughout the 2003 season. I would also like to thank members once again for allowing me to serve as your Honorary Treasurer. Finally thank you to my girlfriend Christie for her patience and understanding throughout the year.

To all members and your families, I wish you a very Merry Christmas and a safe and prosperous 2004

JUNIOR LEAGUE REPORT

Dear Members,

Undoubtedly, the 2003 North Sydney rugby league season was the most enjoyable of the 8 seasons of my rugby league refereeing career. It was an undeniable privilege to represent the North Sydney Referees Association as delegate to the North Sydney Junior League, and feel part of a hard working, close knit and friendly rugby league community.

In recent times, the junior league has placed an emphasis on maximising participation and incentives for the teams participating in the North Sydney competition. The two division format used successfully in the 2002 A Grade competition was again used in 2003, again ensuring competitive matches and maximum interest from all parties right up to the conclusion of the season.

The inaugural Ken Irvine Shield, held at North Sydney Oval this September, extended this admirable concept down to the junior and schoolboy competitions. This competition pitted the winners of the Manly competitions in each age group against their North Sydney counterparts. This gave some teams an opportunity to play opponents they may not otherwise meet. As all participants could better gauge their relative strengths and weaknesses, this competition will help to improve the overall skill level of players across the Northern area of Sydney.

Additionally, the junior league, with the co-operation of clubs from North Sydney and Manly, organised a number of very successful Under 6 gala days, which were enjoyed immensely by all.

These innovations are possible because all of the administrative bodies concerned, from the junior league to our referees association and the clubs of the North Sydney competition, are well run, and able to strike a sensible balance between their own interests and those of the game of rugby league as a whole in North Sydney. It is fantastic to be part of this spirit and have confidence that we are all working towards common goals, and having an enjoyable time in the process.

All of this work can only help boost player numbers in the future.

I would like to thank all of the teams that participated in the 2003 A Grade competition, and particularly Avalon, Belrose, Christian Brothers andNarrabeen for choosing to join us. Every effort was always made to make our officials feel welcome at their grounds, and it was always a pleasure to travel out of the district to officiate at your fixtures.

Congratulations to the Avalon team for winning the Division 2 A Grade Grand Final, and also to the Belrose team for becoming North Sydney A Grade champions for 2003. The A Grade Grand Final in particular was an extremely entertaining match, despite the extremely windy conditions on the day. The young Belrose side built a small lead through the simple, mistake free, well disciplined approach they had employed all year, then their more experienced Narrabeen opponents attacked it right up to the final whistle. The defence from both sides was exceptional.

I cannot wait for the beginning of season 2004, and extend my best wishes to the Junior League and all the clubs. This is a marvellous group to be part of.


